

KUNWAR VIKRAM SINGH ELECTED 2nd VICE PRESIDENT OF WORLD ASSOCIATION OF DETECTIVES



Kunwar Vikram Singh Chairman of APDI was unanimously elected as 2nd Vice President of the World Association of detectives (WAD), the global apex body of Private Investigators and Security Professionals.

The elections took place at the 89th annual conference of WAD held on 21st October 2014 at the Sky City Convention Center, Auckland, New

Zealand. Now Kunwar Vikram Singh is in the line to become Global President of WAD in year 2016 at its annual conference scheduled to be held in New Delhi.

Ms. Christine Vinson from USA was elected Chairman of WAD while Mr. Chuck Mclaughlin from Boston was elected its President.

Mr. Matthias Willenbrink from Germany was elected as 1st Vice President and Mr. Mike LaCorte from UK was elected 3rd Vice President.

Mr. Raymond Pendleton, past President of the WAD administered the Oath to all newly elected Officers and Directors.

To celebrate festival of Diwali, an impressive dance performance by Indian dancers from New Zealand was organized by Indian delegation. The star performer of the evening was Mr. Mahesh Sharma, Secretary General of APDI who enthralled everyone by his solo performance.

Delegates from more than 80 countries participated in this annual event in which various issues were discussed especially related to Criminal Gangs, Corporate Intelligence and International networking of Investigation Professionals.

Mr. V. M Pandit, President of APDI made an impressive presentation of

National Occupational Standards for Private Investigators. These NOS were developed by Security Sector Skill Development Council of India.

Kunwar Vikram Singh Chairman of SSSDC also made presentation of NOS at the Board Meeting of WAD. The ministry will also write to other ministries to associate MANAS with their programmes, especially those related to skill development of minorities, and use the facilities at MANAS for achieving 15 per cent allocation of funds, Dr. Heptulla said.

She further added, "These ministries would be requested to nominate their officers on the board of MANAS to facilitate implementation of their Skill Development Training Programme.

Kunwar Vikram Singh informed him that SSSDC can set up Centres of Excellence in Tribal Areas and organize specialized training to work in mining & Transport Security. Tribal youth can also be trained as Executive Protection.

PRIVATE SECURITY SECTOR NEEDS EFFECTIVE REGULATION - Sh. KIREN RIJJU



Minister of State for Home Affairs, Sh. Kiren Rijju while **speaking at the Conclave, said: "There is a need to regulate the sector more effectively and provide a professional touch to it. Security of a country and its people cannot be left unorganized and it**

must be carried out in a disciplined manner."

Inviting precise recommendations from the industry, Sh. Rijiju said the PSAR Act, passed in 2005 needed to be implemented stringently as the industry has grown at a fast pace and as a result, the act has been unable to provide the requisite support.

The minister also said: "I would take up the issues on priority as private security not only helps in securing people but also provides employment and is a great revenue generator."

He added that he was aware about the issues related to wages of security personnel and the plea of certifying them as skilled labour and was working on resolving these issues. He mentioned "The private sector has so far played a vital role in the private security sector and the government will make all efforts to complement their efforts."

JHARKHAND GOVERNMENT DECIDED TO GRANT LICENCE TO PSA FOR 5 YEARS AGAINST SAME FEE

Govt. of Jharkhand had granted PSARA License to all security agencies for one year in the year 2011-12 which already expired long before. The security agencies had deposited a fee for Rs. 25000/- for whole of state which is applicable for 5 years as per the law. The decision of granting

license for a year was taken by the Home department due to a minor clerical mistake while drafting PSARA State Rules 2010 in which vowel "a" was wrongly typed in English version before word "year" i.e. a year instead of five years. There after licenses were neither extended nor renewed rendering more than 100 agencies of the state license less for last 2 years.

CAPSI Jharkhand Chapter consistently raised the voice against this anomaly but no action was taken. Finally, chapter decided to move to court and for which several information regarding fee, validity period of license, etc. were sought by us through RTI last month. The department had no answer to the RTI enquiry about lapse on their part and finally it was decided to grant fresh license for a period of five years against the same fee already deposited by various agencies.

The decision was to be ratified by the Cabinet which was scheduled to be placed on last Tuesday, but in the mean time election was announced in the state and code of conduct imposed. This was the victory of our consistent effort to amend the provision of model Jharkhand Private Security Agencies Rules 2010.

PRESIDENT OF INDIA INAUGURATES ASSOCHAM SUMMIT ON LIVELIHOOD SECURITY



The President of India, Shri Pranab Mukherjee inaugurated a Summit on **‘Livelihood Security: Realizing the vision for 1.3 billion Indians organized by ASSOCHAM** at Vigyan Bhawan in New Delhi on 3rd November 2014.

Speaking on the occasion, the President said that livelihood security is incomplete without the provision of social security. To make a decisive change in the livelihood security of Indians, the challenges are many and time limited.
